

General terms and conditions

1. Scope of this directive

These General Terms and Conditions (GTC) apply in principle to all offers of the Northwest Switzerland Artistic Gymnastics and Trampoline Centre Liestal (NKL). Deviations are possible for individual offers and are accepted with the signing of the respective registration form.

2. Conclusion of the contract and handling of the data provided

2.1 Registration for a regularly attended offer in a usually fixed group

By signing a registration form for an NKL offer, you conclude an unlimited contract with the NKL Liestal, which can only be terminated at the end of a half year (see point 7). The data provided with the signing of the entry declaration will only be used for internal NKL use and will not be passed on to third parties for commercial use. 2.2 Registration for an irregularly attended course offering (Krabbel- or Kidz-Gym, Free Training, Open Gym, etc.)

By signing the registration form for an irregularly attended course, the participant acknowledges that the acknowledge that the handling of the personal data provided is regulated according to the explanations in the privacy policy.

2.3 Purchase a subscription for certain course offerings

The subscription is valid for the agreed duration. The conditions listed under point 8 do not apply to offers with a subscription.

3. E-mail address

We send various information by e-mail from time to time. The specified e-mail address should be in regular use. It should also be an e-mail address that, in the case of fixed training groups, other participants or their legal guardians may also know. Furthermore, the e-mail address is also used for invoicing (see point 4).

4. Invoicing

Invoices are usually issued semi-annually at the beginning of a new semester or when a subscription is purchased. Participants who join during the semester pay a pro rata fee from the date of joining or trial training (exceptions are indicated in the corresponding offer). Terms of payment 30 days net from date of invoice. Invoices will be sent to the email address provided (A processing fee of CHF 5 per invoice will be charged for invoices sent by mail). Exceptions: If an enclosure is sent with the invoice, it will be sent by post as an exception.

5. Photos

During training sessions, photos or videos may be taken, which will be published on the homepage and used for NKL promotional purposes on flyers and social media. By signing the registration, consent is given to use these recordings for marketing purposes of the NKL. The NKL will use these images and videos for its own purposes only and will not share them with third parties for commercial use.

6. Insurance

Insurance is the responsibility of the participants or their legal guardians. With the signature it is confirmed that the participants are privately insured against accidents. The Rosen AG Artistic Gymnastics Centre, as the owner of the hall, or the NKL, as the hall operator, declines all liability. This applies in particular to improper use of the halls and the equipment therein. Unauthorized persons are not allowed to enter the halls without a trainer or without registration.

7. Cancellation

The contract for the regularly attended training groups can be terminated at the end of each half year (30.6. or 31.12.) in writing by e-mail or letter to the NKL office (info@nkl-liestal.ch). Without written cancellation, the contract is tacitly extended.

If a cancellation is made for unforeseeable reasons (e.g. accident, illness) until mid-January or mid-July, the fee remains due until the end of March or the end of September. The offer can be continued during this time. The end date is decisive for offers with a subscription. The subscription is not automatically extended, but must be renewed.

8. Refund

Early withdrawal does not entitle the participant to a refund of the fee paid. Absences of more than one month due to accident or illness must be documented by a doctor's certificate for regularly attended programs. This must be submitted to the NKL office (info@nkl-liestal.ch) within 10 days of the beginning of the sick leave so that it can be checked whether the absence can be credited for the next semester. Certificates submitted too late will not result in a claim for consideration for possible credit toward the next semester's tuition. Shorter absences can be made up after consultation with the responsible coach. This rule does not apply to athletes in the three performance areas or to season ticket holders.

9. Place of jurisdiction

The Swiss Code of Obligations shall apply. The place of jurisdiction shall be the registered office of the Northwest Swiss Artistic Gymnastics and Trampoline Centre Liestal.
